

# Temporary Importation Bond

*This chapter provides record formats to change and receive an expiration date for a Temporary Importation Bond.*

## RECORD DESCRIPTIONS

**Record Identifier XA (Input)..... .. TIB-3**

This is a mandatory input record that allows a filer to request an extension of a temporary importation bond (entry type code 23).

**Record Identifier XO (Output).... .. TIB-4**

This is a mandatory output record that provides notification of the results of the request for the extension of a temporary importation bond.

**Record Identifier X1 (Output)..... .. TIB-5**

This is a mandatory output record that provides notification of when a temporary importation bond (TIB) is due to expire. This record is only returned for entry type code 23 (TIB) summaries.

# Temporary Importation Bond

Temporary Importation Bond (TIB) records allow a filer to request an extension of a TIB, provides notification of the results of the request for an extension and provides a list of TIB entries that are about to expire.

## **Expiring TIBs**

ACS automatically provides notification to an automated filer when a TIB is about to expire (within one month).

***Input:*** There are no input records.

***Output:*** Record Identifier X1 is a mandatory output record.

The application identifier on Record Identifier B is TS. For additional information on Record Identifier B, refer to the Application Control chapter of this document.

## **TIB Extensions**

ACS filers have the capability to request a TIB extension.

***Input:*** Record Identifier XA is a mandatory TIB input record.

The application identifier on Record Identifier B is XN. For additional information on Record Identifier B, refer to the Application Control chapter of this document.

***Output:*** Record Identifier XO is a mandatory TIB output record that provides the results of the request for a TIB extension.

The application identifier on Record Identifier B is XS. For additional information on Record Identifier B, refer to the Application Control chapter of this document.

## **Record Identifier XA (Input)**

This is a mandatory input record that allows a filer to request an extension of a temporary importation bond (entry type code 23).

## **Record Identifier XO (Output)**

This is a mandatory output record that provides notification of the results of the request for the extension of a temporary importation bond.

**Record Identifier X1 (Output)**

This is a mandatory output record that provides notification of when a temporary importation bond (TIB) is due to expire. This record is only returned for entry type code 23 (TIB) summaries. This record serves as an alert to the filer that a TIB is about to expire and a penalty may result if no action is taken.

Total Number of Extensions	1N	37	C	A number representing the total number of times the temporary importation bond entry summary has been extended.
